Customers of Banca Monte dei Paschi di Siena and Widiba will be able to transfer money between accounts in just a few seconds, 24 hours a day, 365 days a year, throughout all SEPA countries

Milan, Siena, 17 February 2020 - The Montepaschi Group has chosen Nexi's platform to launch its instant bank credit transfer service. Starting in February, customers of Banca Monte dei Paschi di Siena and Widiba will be able to transfer or receive amounts of up to €15,000 in just a few seconds, 24 hours a day, 365 days a year, throughout all 34 SEPA countries. The features of the Instant Payment service will be progressively rolled out to all device channels, starting with Digital Banking.

Thanks to the agreement with EBA Clearing and the connection with TIPS (Target Instant Payment Settlement), Nexi's platform makes it possible to reach all Italian and European banks that have activated the instant transfer service.

There are many advantages for both individuals and businesses: from the ability to pay for purchases in real time to urgent payments falling due and immediate confirmation of receipt of payment for goods sold, in Italy and abroad.

The instant transfer service reinforces the partnership with the PayTech firm in an environment of rapidly evolving payment systems, allowing the Montepaschi Group to offer increasingly efficient services to its customers and Nexi to consolidate its role as a company specialised in digital payments at the service of Italy's banks.
